Amendment 1 - **Vote No**

Brings politics into local school boards by ending non-partisan elections.

Amendment 2 - **Vote No**

Makes fishing and hunting the "preferred means" of managing fish and wildlife.

Amendment 3 - **Vote YES**

Legalizes the recreational use of marijuana for adults 21 and over.

Amendment 4 - **Vote YES**

Limits the ability of politicians to interfere in the private health care decision to have an abortion.

Amendment 5 - **Vote No**

Increases the homestead tax exemption while cutting funding for programs and services for communities.

Amendment 6 - **Vote No**

Ends Florida's campaign financing program that incentivizes support from everyday citizens, not wealthy donors and special interests.
